The Republic of Serbia / Republic Geodetic Authority has received financing from the World Bank toward the cost of the Real Estate Management Project, and intends to apply part of the proceeds for consulting services to skilled professionals, on a full time basis, for a one-year period as a members of the Implementation team of Integrated System of Real Estate Cadastre (ISREC). The IT system implementers will be engaged for the activities which are related to the implementation of the ISREC and other IT systems at the Republic Geodetic Authority as well as for the all activities related to the Component B - E-governance for Enabling Access to Real Estate Information and overall IT activities that will be performed through the REMP Project in the RGA. These consultants will also participate in activities which are related to the establishment on the National Spatial Data Infrastructure which will be established in compliance with the European Standards. The IT system implementers will be part of the RGA IT Department team.

The Consultants shall work as a team in order to support implementation of ISREC (DQI, Phase 1, Phase 2 and Phase 3) and all other IT systems to be implemented in RGA, Provide first line support of the end users at all RGA branch offices during the implementation of all IT systems, support debugging of software errors during Operational Acceptance testing phase, provide first line support diagnostic of software or infrastructure problems during daily activities of all RGA offices and reporting incidents to vendors or suppliers, participate in the installation of hardware and software for successful implementation of all project activities, participate in configuration and maintenance of hardware and software for successful implementation of all project related activities, provide customized statistical reports related to ISREC system on demand, and provide support to surveyors and lawyers in the process of data quality improvement.

The consultants shall be based in RGA headquarters and will travel to branch offices as necessary for completion of the above mentioned tasks.

The Republic Geodetic Authority now invites eligible individual consultants to indicate their interest in providing the Services. Interested Consultants should provide Cover Letter and CV demonstrating that they have the required qualifications and relevant experience to perform the Services.

The shortlisting criteria are:

Essential:

- High school graduate
- Computer literacy (MS Office).

- Minimum 12 (twelve) months of practical experience in developing/ administration of data models, developing/ administration of software applications and developing/ implementation of database.
- Knowledge and understanding of cadastral information systems.
- Fluent English language speaking and writing skills.

The following will be considered as an advantage:

- University degree in Computer Science - IT.
- Experience in implementation of WEB based software applications.
- Experience in deployment and maintenance of server virtualization environment.
- Experience in storage systems and backup solutions.

In reference to the required knowledge and experience, the IT experts during the application process must provide adequate i.e. relevant documents (in scanned form or copies) proving that they possess the required working experience in the stated area.

The following selection criteria with corresponding points will be used for the above three positions in the evaluation procedure:
